## **Stay Informed:**

#### African American History Digitization Project

In preparation for a small exhibit on the Still family from Burlington County, the National Museum of and Culture requested a digitized scan of a map from *Combination Atlas Map of Burlington County*, *New Jersey* by J.D. Scott, 1876, held in the State Library's collection. Our staff was able to produce a high-quality image of the map requested using the new digitization equipment acquired earlier in 2023.

#### The NJ Attorney General's Library

In 2023, the State Library took on management of the New Jersey Attorney General's Library. The Attorney General's Library exclusively serves the staff of the New Jersey Department of Law & Public Safety. The AG's Library joins the Environmental Research Library of the New Jersey Department of Environmental Protection, which is also managed by the State Library, in addressing unique research needs for two of the state's largest agencies. In addition, the State Library supports the Department of Transportation's Library by providing cataloging and circulation services.
